Phase 1:

The primary outcome of the Delphi-study is an age-specific checklist to identify elderly patients with a personality disorder in need of highly specialized care.

Phase 2:

The primary outcome of the validation study is a cut-off point for the checklist with optimal specificity and sensitivity.

Secondary outcome

In the second fase the interrater reliability of the checklist will be determined as well.

Study description

Background summary

Recently a decision tool has been developed to identify adults with personality disorders in need of highly specialized care. Because of age-specific aspects of personality disorders (for example because of) it can not be assumed without question that this decision tool is suitable for elderly. In the first part of this study, based on expert opinion, the decison tool for adults will be adjusted for an elderly population. The second part of this study is a validation study of this new tool.

Study objective

The aim of this study is to develop and validate an age-specific checklist that can help clinicians to identify elderly patients with personality disorders in need of highly specialized mental health care.

Study design

The expertmeeting is planned in september 2016.

Inclusion for the validition study starts in january 2017.

Intervention

Phase 1: patricipation in an expertmeeting by selected experts.

Phase 2: filling out the checklist by the clinician.
